



# Organizational Structure







### Council of Ministers

 Ultimate responsible political authority and is accountable to Parliament accordingly for decisions made and about the performance of their Ministries.

 Any political dialogue on National Development will be executed by Ministers in Parliament.





# Steering Committee NDP

PM (chair), SG's, representatives Private Sector and Civil Society: Carry full accountability of the outcome of the social dialogue, national development plan and MDG's. Estimated time contribution: min of 8 meetings per year.

- 1. Mandate the projects operational arrangements.
- 2. Oversee the coordination of the projects execution.
- Performance monitoring and evaluation of the project activities.
- 4. Provide advice, observations and feedback to the Work Group NDP.





# Working Group NDP

# Focal points appointed per Ministry + representation Private Sector and Civil Society

To facilitate the implementation of specific activities resulting in a National Vision, Development Plan and a MDG Accelerated Action Plan (MAF)

- Provide and share information with the project team and accountable parties.
- 2. Divide and direct tasks within different ministries concerning the projects implementation.
- 3. Regularly review the status of project objectives activities, outputs, risks and emerging issues.
- 4. Participate in the nourishment of the social dialogue process.





### Team NDP BAK

#### **BAK - Implementing agency**;

Leads the project and is liaison between UNDP and the Prime Minister. Fulltime contribution.

- Coordinates the project and functions as secretariat in SC and WG meetings.
- 2. Obtains and allocates resources for the project.
- 3. Reports on annual expenditure.
- 4. Guides the planning.
- 5. Assists and facilitates the executing part of the project/ hires external expertise where needed.
- Manages inter-ministerial coordination within Government.

 Informing the public while achieving openness and transparency



# The Millennium Development Goals

### Introduction

- In 2000 Millennium Declaration UN (89 Countries) Geneva
- 8 Goals formulated to reach 2015.
- NEA adopted program in 2009.
- First MDG report Cur-SXM 2011 (Data mainly census 2001)
- MDG report basis for NDP SXM (data collection from 2011 census)
- Budget: See Overall (part of MDG's)







# Millennium Development GOALS

















For each goal we use the Caribbean Indicators





# Goal 1 and Indicator



- Reduce with 50% proportion of people living on less than 1\$ a day and people who suffer from hunger
- Achieve full employment for all





### GOAL 7 AND INDICATORS

- Integrate principles of sustainable development in to country policies/ programmes.
- Reduce biodiversity loss by 2010 a significant reduction.
- Reduce 50% of people without access to safe drinking water/basic sanitation.







### MDG'S NEEDED FOR SXM? YES!

Although Sint Maarten doesn't have poverty on an alarming scale, it has advantages by enforcing some MDG'S in its socio economic plan f.e:

- Create full employment & better control food prices.
- More Environmental laws and awareness.
- More Regional Cooperation on development.
- Primary Education for all.
- Deal better with our depth problem Better Health (Asses HIV/AIDS medicines).





# MDG Process ties in NDP process

- MDG report = Basis for NDP
- MDG Work group = Coordinating group (coordinating body/process to make report and data collection for feeding the NDP)
- Government (cross ministerial),
- NGO on most important goals &
- Private Sector (goals 7 and 8)
- Overlap with 4 themes NDP, Data collection feeds NDP.







# **MDG** Organizational

 Former MDG Workgroupconsisting of Gov/NGO/Private coordinating body/process to make report and data collection for NDP.

- Tasks: coordination of dialogue within their entities
- ➤ Data Collection for MDG report 2014 (STATT important!)
- ➤ Puller within their ministries for MAF

### Two outputs:

- 1. Factsheet on current situation: this will be used as baseline for the democratic dialogue process towards the development of NDP
  - 2. MDGs Acceleration Framework





### SWOT-TARGET GROUP

### **Target groups:**

- Public servants Ministries & Departments
- Private Sector-businesses, companies
   & firms
- Civil Society Organizations-NGOs, Community Based Organizations, youth, women's groups, religious groups, etc
